Abington Township Update on SPS Technologies Incident

ABINGTON, PA: As of February 19, 2025, at 6:30 PM, the fire at SPS Technologies located at 301 Highland Avenue **remains active and investigations are ongoing.** Emergency personnel will continue to work over night to ensure public safety.

The information within today's 11 AM press release remains in place. The Shelter-In-Place and Evacuation recommendation are lifted. As such, the evacuation shelter at Cheltenham High School has closed and Southeastern Pennsylvania Transportation Authority's (SEPTA) Glenside, Jenkintown, and Noble train stations have reopened.

We are asking all residents to avoid the area. Sections of the SPS Technologies building are structurally compromised and it is an active emergency scene. There is **absolutely no trespassing on the site** for the safety of all the emergency responders and public.

The United States Environmental Protection Agency (EPA) continues to monitor air quality. Based on the data collected, the monitoring equipment has not detected levels of contaminants of public concern. Pennsylvania Department of Environmental Protection (DEP) and the Philadelphia Water Department (PWD) have conducted an initial sampling of the Tookany Creek; **low levels of chemicals of concern were found in the creek** immediately downstream of the fire. There are no drinking water intakes from Tookany Creek. DEP has re-sampled the creek today and **the results of those tests are not yet available**. Samples taken from the Delaware River did not detect any chemicals of concern. Drinking water supplies are not at risk.
