





New Activities and Pilot Projects

- Township Hired Consulting Arborist in August 2024
- Proposed Tree Preservation, Protection, and Removal Ordinance
- Development of a Invasives Plant Management Plan for Township Parks
- Pilot (with EAC) Native Plant Gardens for Park Stewardship
- Pilot Pennsylvania Outdoor Corps for Stewardship

TREE PLANTINGS AND FREE TREE GIVEAWAY

- 100 TREES PLANTED IN TOWNSHIP PARKS, SCHOOLS AND NATURAL AREAS
- 2024 and 2025 (to date): 900 trees have been distributed to 529 Abington households. In Fall 2025, an additional 300 trees will be given away to Township residents

Free Tree Giveaways

- Our **biannual free native tree giveaways** for township residents continue to be our most popular event.
- The STC has given away 2,000 trees to since 2022. In October 2025, another 300 trees will be distributed.








Native Tree Giveaways

Renewed Call to Action: Protect and Grow Our Urban Forest

FAST FACTS

- Abington's tree canopy is in decline. Between 2004–2017 we lost over 420 acres of tree canopy, or 1 in 8 trees.
 And canopy decline continues.
- Abington's tree canopy is inequitably distributed. We have **as little as 1 tree per person in ward 5** to as many as 7 trees per person in ward 1.




WHY IT MATTERS:

- Trees are a vital part of Abington's infrastructure and provide numerous ecosystem services, including reducing stormwater runoff and flooding and improving water quality.
- Trees cool neighborhoods, reducing the urban heat island effect and saving energy costs.
- Trees make Abington a more desirable place to live, and they increase the property values of neighborhoods with more trees.

Priorities

Master Tree Action Plan (MTAP)

- The Master Tree Action Plan (MTAP) helps protect our urban forest and the ecosystem services it provides.
- Implementation Actions:
 - Free Tree Giveaways
 - Park Plantings
 - Native Plant Gardens for park stewardship
 - Hiring consulting arborist
 - Proposed Tree Preservation, Protection, and Removal Ordinance
 - Invasive Plants Management Plan

Proposed Tree Preservation, Protection and Replacement Ordinance

WHY DO WE NEED PROTECTIONS FOR OUR TREES?

• Our tree canopy is vanishing at an alarming rate. Our current tree preservation, protection, and replacement guidelines are outdated and contain gaps.

• The proposed ordinance will adopt best practices from other municipalities that reflect current national standards. It will help protect and grow our urban forest during future land development and streamline review of development plans.
